CONDUCTED a public hearing concerning the Optional Flexible School Day Program at OPTIONS, Texas High School, and Texas Middle School. This program allows the District to offer a

program with flexible hours and days of attendance to certain students who are at risk of dropping out of school; the application must be filed annually. Three members of the audience asked questions concerning this program; Nanette Power responded to the questions.

**RECEIVED** information from Superintendent Paul Norton that the legislative session continued to

address issues such as accountability and the high school graduation program. Mr. Norton also presented a report on proposed changes that would affect the Dunbar Intermediate Center, Theron Jones Early Literacy Center and Westlawn Elementary, He discussed the realignment plan, noting that the district will conduct a series of parent meetings in mid-March. He also informed the Board of an upcoming field trip request from Texas High School TigerVision to Los Angeles, California 3-5-2013 – 3-10-2013 where students

will attend workshops and compete in competition in areas of this field.
